In return, in registering as a member of our database, the following terms and conditions apply to all.

Registration

- 1** All information provided on your application and / or to any member of Extras Ireland must be truthful.
- 2** In compliance with Irish Employment Laws, you must be in possession of a valid PPS number to work with us.
- 3** Your details will remain on the Extras Ireland database until you request us to remove your details. We will do so immediately when requested.

Availability Checks & Job Offers

- 4** You are free to register with other Agencies as you wish but we will act as your Agent / Representative for any jobs we consider / book you for.
- 5** You are never obliged to accept jobs we may offer you. You are always in control of which roles you would like to be considered for and / or accept.
- 6** You must ensure that the photos we have on file of you are up to date at all times so that we and Clients can be sure of your current appearance. We will always check this with you before suggesting you for any role.
- 7** As you can understand, project and shoot details are strictly confidential and you must not disclose internal information to any media including newspapers, social media and blogs.
- 8** If there is anything you are unsure of, for example call time, location, wardrobe notes, always be sure to ask.

On Set

- 9** It is your responsibility to arrive to set on time, with any costume you have been requested to bring.
- 10** Photographs and / or videos while on set are prohibited, unless agreed to by the Production Company.
- 11** You are responsible for any costume or accessories provided to you while on set. If something is lost or damaged while you have it, you will be required to pay for it and this may be deducted from your wages.
- 12** Production may dismiss you from a set for any of the following reasons - arriving late, not bringing the correct wardrobe, being disruptive, rude or not following direction, being under the influence of drugs or alcohol, or by acting in such a way that the safety of others may be hampered.

Removal From Database

- 13** If we receive complaints in relation to point 12 above or actions which affect our reputation as a professional and reliable Agency, Extras Ireland may delete your information from our database of Talent.
- 14** If, for any reason, you can no longer attend a job for which you have been booked and confirmed, you must inform Extras Ireland immediately so that we can find a suitable replacement for our Client. Failure to do so will result in you being removed from our database of Talent.
